Introduction, Purpose, and Goals of this Community Needs Assessment

Community needs assessments are tools public health professionals use to collect, synthesize, and disseminate valuable information to support and validate decision-making and commitments to implementing community health interventions, resources, and investments. Capturing insight about the current health status and potential accomplishments as well as deficiencies in community services and community resources inform key stakeholders—both within and outside the healthcare sector—who are committed to delivering culturally competent services to the LGBTQ+ community. This contributes to the overall improved health status of the target population.

Community needs assessments are an essential tool for identifying the strengths, opportunities, and resources available in a community to meet the unmet needs of the people living there. Community needs assessments also provide valuable insight and information for identifying and developing innovative solutions to service gaps and building a supportive community to live in. As LGBTQ+ individuals and as a community, we have abundant strength, resilience, and resourcefulness. At the same time, our community continues to be disproportionately affected by a range of physical, mental, and behavioral health, economic, social, legal, and political issues. Many organizations may overlook our needs because they don't understand what our needs are.

Goals:

- Increase awareness about public health as it relates to the LGBTQ+ community in Greater Cleveland
- Lean into the local LGBTQ+ population demographically as the LGBTQ+ community is currently unassessed by the US Census, leaving us to rely on estimates
- Describe the status of the local LGBTQ+ community holistically; not just focusing on weaknesses and unmet needs but also identifying strengths and achievements
- Develop a set of community recommendations based on participant input that inform future investments and decision-making for the local LGBTQ+ community
- Strengthen partnerships and collaborations between organizations within the local public health system



Research Methodology

Planning

The Greater Cleveland LGBTQ+ Community Needs Assessment was conducted from January 2023 to December 2024 using a communitybased participatory research (CBPR) approach. This approach prioritized collaboration with LGBTQ+ community members and stakeholders across diverse sectors. The project was guided by nine committees: a Steering Committee, a Diversity, Equity, Inclusion, and Belonging (DEIB) Committee, and seven sub-committees, collectively representing a holistic approach to community health. These sub-committees included Health and Wellness, Religion and Spirituality, Education and Literacy, Housing, Food, and Basic Needs, Business, Employment, and Commerce. Safety and Law Enforcement. and Recreation and Leisure.

These leadership teams were composed of over 180 individuals from more than 120 organizations, including health services, educational institutions, and LGBTQ+ advocacy groups. The planning process, facilitated by a Program Director and four graduate students from Kent State University's College of Public Health, involved developing clear objectives, establishing recruitment strategies, and identifying key community issues to assess.

Each sub-committee, consisting of LGBTQ+ community members, subject experts, professionals, and stakeholders, participated in a series of ten 90-minute virtual meetings. These meetings guided the teams in defining the Greater Cleveland LGBTQ+ Community, conducting SWOT analyses, identifying concerns, determining researchable questions, and selecting appropriate data collection mechanisms. The sub-committees' work was reviewed by the Steering and DEIB committees, with feedback incorporated through monthly virtual meetings.

Data Collection

Community Survey

The primary means of data collection was a comprehensive digital survey co-developed by the project committees to cover critical health domains and community needs. Recruitment occurred through social media, in-person engagement at LGBTQ+ community events and significant venues, and flyer distribution in collaboration with community partners across

Cuyahoga, Geauga, Lake, and Lorain counties. The core project team attended and posted flyers at over 120 events and venues. Participants included individuals aged 12 or older, with parental consent for those under 18, identifying as LGBTQ+ or LGBTQ+ allies living in the target counties or relying on Greater Cleveland for resources. Survey participants were incentivized with a raffle for one of 35 gift cards from local LGBTQ+-owned or affirming businesses valued at \$75 each.

Survey metrics reveal that the Greater Cleveland LGBTQ+ Community Needs Assessment gathered a total of 2,006 unique survey responses. Of these respondents, 1,653 (82.5%) identified as LGBTQ+, with 1,594 adults and 59 youth. Additionally, 353 (17.5%) respondents identified as LGBTQ+ allies, including 350 adults and 3 youth. The BIPOC LGBTQ+ response rate was 22.4% (371 responses). The overall completion rate was 75%. There were six surveys completed in Spanish. In total the community survey collected 363,041 unique data points.

Stakeholder Interviews

Semi-structured interviews were conducted with 23 key stakeholders from community organizations, healthcare providers, and government. These interviews aimed to gather indepth insights into the systemic challenges faced by the LGBTQ+ community and identify potential areas for intervention. Stakeholders were selected for their expertise and involvement in LGBTQ+ issues, ensuring diverse perspectives. Interviews were anonymous, recorded, transcribed, and thematically analyzed to highlight common concerns and strategic recommendations for improving community health outcomes.

Intersectionality Listening Sessions

Intersectionality listening sessions (focus groups) were held with historically underrepresented subcommunities, identities, subgroups, and shared experiences. These sessions employed a qualitative approach to create a safe space for participants to share their specific challenges and needs. A total of 178 participants engaged in 26 ninety-minute sessions held at the LGBTQ+ Community Center of Greater Cleveland, El Centro De Servicios Sociales, Colors+, Geauga Public Library, Lake County Health Department, and B. Riley Sober House. Participants were compensated with a \$50 prepaid Visa gift card for sharing their time and experiences with the project. Facilitators led guided discussions to identify and prioritize unmet needs, existing resources, barriers to access, and potential solutions and calls to action. The insights from these sessions were crucial in ensuring underrepresented voices were central to the needs assessment process.

Analysis

Data analysis involved both quantitative and qualitative methodologies. Quantitative data from the community survey were analyzed using descriptive statistics and published in this full community report to provide a broad overview of the LGBTQ+ community's needs. Qualitative responses, particularly from open-ended questions, were analyzed thematically through coding and categorization using a three-person protocol, with independent reviewers identifying recurring themes related to fears, concerns, and suggested improvements. Intersectional analysis was applied to understand the unique challenges faced by individuals with intersecting identities, enriching the overall findings of the assessment.

Dissemination

The findings from the needs assessment were disseminated through multiple channels to ensure broad accessibility and community engagement. Preliminary results were shared at community forums, stakeholder meetings, and LGBTQ+ events to facilitate dialogue and feedback.

• A comprehensive report, including both quantitative and qualitative findings, was submitted for peer review and made available on the project's website, LGBTQOhio.org.

Additionally, infographics summarizing key findings and actionable recommendations were developed for distribution across community organizations and social media platforms to maximize outreach and impact.

Strengths

- **Robust Participation:** The assessment recorded 2,006 valid and unique survey responses, providing a rich dataset with a high completion rate that reflects the diverse experiences within the LGBTQ+ community of Greater Cleveland.
- **Mixed-Methods Approach:** Utilizing both quantitative and qualitative data allows for a comprehensive understanding of the community's needs and priorities.

• **Community-Partnered Approach:** The project piloted a recruitment method that equitably compensated eight community organizations and individuals with access to hard-to-reach LGBTQ+ subcommunity members, working hand-in-hand with the core project team to recruit potential participants for the survey and listening sessions, increasing the diversity of the final sample.

Limitations

- Sampling Bias: The non-probability convenience sampling approach led to potential underrepresentation of certain intersections within the LGBTQ+ community, such as intersex individuals, LGBTQ+ youth of diverse racial and ethnic backgrounds, LGBTQ+ individuals experiencing homelessness or housing insecurity, LGBTQ+ seniors (over 65), and LGBTQ+ individuals from Middle Eastern, North African, Asian American, Pacific Islander, and American Indian and Native Alaskan backgrounds.
- Access Barriers: Further local research with these identities in particular should be conducted in the future to better understand and meet the needs of these LGBTQ+ community members.
- Age Restriction: Data collection did not include LGBTQ+ community members under the age of 12, which may overlook critical insights from younger demographics.
- Self-Reported Data: The assessment relied on self-reported data, which can be subject to biases, including over- or under-reporting behaviors, experiences, or needs. Respondents may have provided socially desirable answers rather than accurate reflections of their circumstances.
- **Response Bias:** Certain groups may have been more likely to participate in the survey or focus groups, leading to a response bias. Individuals who are more engaged or have stronger opinions may have skewed the results toward those perspectives.
- Limited Generalizability: Due to the nonrandom, convenience sampling method, the findings may not be fully generalizable to the entire LGBTQ+ population or to other regions outside Greater Cleveland. The specific needs identified may be unique to the respondents.

Community Recommendations for Addressing LGBTQ+ Needs

The following table presents a prioritized list of community recommendations derived from our qualitative community survey question, "What do you need to address your biggest fear, worry, or concern for yourself as a member of the LGBTQ+ community?" These recommendations aim to identify and address the most pressing fears, concerns, and worries expressed directly by community members.

The recommendations are sorted by priority, with the most frequently identified priorities at the top. Through a three-person thematizing analysis, 1,352 themes were identified from 830 qualitative responses, which were organized into 34 community recommendations. The top 20 community recommendations are depicted in this table.

Community Survey

Unified Community Definition

For the purpose of this project, when referring to the LGBTQ+ Community of Greater Cleveland, we mean anyone who identifies with marginalized sexual orientations and gender identities such as Lesbian, Gay, Bisexual, Transgender, and/or Queer or Questioning. This includes individuals whose identity may not be expressly included in the acronym LGBTQ+, or may not publicly identify or "out" themselves but still feel they belong to the community.

The LGBTQ+ Community of Greater Cleveland encompasses those who live or work in Cuyahoga, Lake, Lorain, or Geauga counties or rely on Greater Cleveland for Healthcare, Social Services, Employment, Education, Religion or Spirituality, Recreation, Community Resources, or Support to satisfy their needs.


In your day-to-day life, how often do any of the following things happen to you related to your experience of racial discrimination?




In your day-to-day life, how often do any of the following things happen to you related to your experience of homophobia?

Health and Wellness




For the purpose of this project, we take a holistic approach to health and wellness, encompassing respondents' needs and concerns across all dimensions of well-being, including physical, mental, behavioral, emotional, social, sexual, medical-legal, occupational, and spiritual health, throughout their lifespan. We understand the various factors that impact health and wellness, such as access to quality care and coverage, and acknowledge the importance of health literacy in health issues that disproportionately affect the LGBTQ+ community.

To achieve health equity, we recognize the need to assess institutional and community barriers that limit healthcare access, such as stigma and discrimination. We advocate for traumainformed, gender-affirming, and culturally competent care to ensure that LGBTQ+ individuals have access to competent healthcare providers. We acknowledge the challenges faced by rural LGBTQ+ communities in accessing culturally competent healthcare services, and the need for alternative and community spaces for providing healthcare and prevention services.


We also recognize the importance of continuity of care across institutions serving the LGBTQ+ community, as well as the needs of caregivers, including healthcare proxies and power of attorney. We acknowledge and welcome the involvement of LGBTQ+-identifying healthcare providers in providing competent and inclusive care.

Additionally, we prioritize wellness by providing coping skills specific to the LGBTQ+ community, and promoting self-advocacy, education, and training. We acknowledge the value of collecting Sexual Orientation and Gender Identity data and implementing appropriate data standards.














How often do you have a drink containing alcohol?


















Are you currently receiving gender-affirming hormone treatment?




Are you under the supervision of a licensed medical professional for your gender-affirming hormone treatment?


Do you use telemedicine to access your gender-affirming hormone treatment licensed medical provider?


Which of the following best describes your gender-affirming hormone treatment access? (select all that apply)


We recognize that definitions of religion and spirituality are diverse and individualistic and that seeking guidance beyond oneself and connecting with a higher power can take many forms.

This domain emphasizes identifying concerns related to the inclusion of LGBTQ+ individuals in religious and spiritual communities, exploring the impact of religion and spirituality on health, promoting greater understanding and acceptance, and assessing the historic religious trauma of LGBTQ+ individuals within diverse religious and spiritual traditions.













Have religious teachings about gender identity, gender expression, or sexual orientation ever made you feel a diminished sense of self-worth?




To what level do you consider yourself to be religious or spiritual?







How often do you turn to your religion or spirituality to help you deal with problems in your life?



How often do you participate in individual spiritual practices alone? (such as praying, meditating, or some other individual spiritual practice)







In our efforts to ensure equal access to education and literacy resources, we aim to assess the barriers around safety and policy initiatives related to LGBTQ+ topics/issues.


Have you been enrolled as a student in the past five (5) years?





What kind of education program, certification, or training are/were you enrolled in?



Do you plan to continue your education after high school?




How often have you been worried about your physical safety in your educational setting(s)?


Which of the following settings have you avoided due to fear for your physical safety (select all that apply)
















Are you satisfied with your current living arrangements?






What factors are most important to you when choosing your home or apartment? (select all that apply)




How many people live in the place where you stay? (including yourself)








How often did you experience food insecurity in the past?

Where do you usually get your groceries? (select all that apply)






Do you have a smartphone with internet access? (a phone that also has computer capabilities and accesses the internet)







Limited benefits and policies: HR may not provide sufficient benefits and policies that support LGBTQ+ individuals, such as non-discrimination policies, equal access to healthcare, or support for transitioning in the workplace, which can make it difficult for LGBTQ+ individuals to feel safe and supported in the workplace.






What kind of workplace discrimination have you experienced based on your sexual orientation or gender identity (select all that apply)?




Does your current employer have rules/regulations/policies in place for those who have experienced workplace discrimination based on their sexual orientation or gender identity?




Safety and Law Enforcement



We recognize that creating a safe physical space involves more than just the presence of law enforcement and is an inter-professional responsibility. Therefore, we aim to assess various aspects of safety preparedness and raise awareness of available safety and law enforcement from historical views and experiences, and prioritize professional development opportunities for people in positions of power to better understand the experiences of those most affected, including intersectional LGBTQ+ identities.






Have you ever experienced LGBTQ+ discrimination in the following places or situations? (select all that apply)




Are there certain parts of Cuyahoga, Lake, Lorain, or Geauga counties that you worry about your safety or acceptance because of your LGBTQ+ identity?




Have you been arrested, detained by, or had a negative interaction(s) with a law enforcement officer or the justice system in the past five (5) years?




How often are the following statements true pertaining to your arrest, detainment or interactions with the justice system?


Did you use any kind of personal legal help or services in the past five (5) years?


Where did/do you usually get these legal services? (select all that apply)


How often are the following statements true pertaining to your interactions with legal services?




Do any of these make it hard for you to get legal support? (select all that apply)


Whether or not you have personally needed legal help, how important do you feel it is it that LGBTQ+ specific lawyers or other legal services are available?






In the past five years, have you ever been bullied because of your LGBTQ+ identity?








In general, do you prefer LGBTQ+ specific programming and events over general community programming and events?




Do you think being LGBTQ+ is a choice or something you are born with?



Do you feel like you are up to date and generally know what LGBTQ+ issues are most important right now?




To the best of your knowledge, are LGBTQ+ individuals protected from employment, housing, and public accommodation discrimination in Ohio?








How comfortable do you feel standing up for LGBTQ+ people as an Ally at the following places? 294 Responses




In the past year, how often would you say you have supported an LGBTQ+ person or people?








How often do you hear or see the following things happening by others?




To what level or degree have you observed an LGBTQ+ person being discriminated against in the following settings?






Do you feel supported by others as an LGBTQ+ Ally?




In your experience, how impactful have these factors been in identifying as an LBGTQ+ Ally yourself?




How much LGBTQ+ support would you say there is in the community where you live?



Understanding Our Intersectionality Community Spotlights

We are excited to introduce our intersectionality community spotlights, a series of printable information sheets designed to bring awareness to the health status, community priorities, and calls to action from members of historically marginalized, underserved, and hard-to-reach identities and experiences within the LGBTQ+ community.

These spotlights are compilations of data and insights gathered from our intersectionality listening sessions (focus groups) and community survey.

The Importance of Intersectionality

Intersectionality is a critical framework for understanding how various aspects of a person's social and political identities (such as gender, race, class, sexuality, ability, etc.) combine to create different modes of discrimination and privilege. For LGBTQ+ individuals, these intersecting identities can significantly influence their lived experiences, particularly in terms of health equity and access to resources.

Spotlighting these diverse communities is an attempt to bring this crucial information to the forefront of societal consciousness. By highlighting the unique challenges and needs of various subcommunities within the LGBTQ+ population, we aim to foster greater awareness, empathy, and informed action.

The health inequities faced by LGBTQ+ individuals are often compounded by additional layers of marginalization. For instance, Black transgender women may face not only transphobia but also racism and sexism, which together can exacerbate their struggles with accessing adequate healthcare and support services. By compiling and presenting this data, we aim to illuminate these complex realities and advocate for holistic, inclusive solutions.

Each spotlight is crafted to serve a dual purpose: it can be read as part of this comprehensive report or printed as standalone info sheets to be distributed or posted on bulletin boards to raise awareness within the community. Our goal is to ensure that these pages are not only informative but also accessible and actionable.

When possible, the intersectionality community spotlights include the following data points:

- Health Insurance Coverage: The percentage of community members sampled without health insurance. Note: LGBTQ+ youth under 18 were not asked this question.
- Housing Insecurity: The percentage of community members sampled who reported experiencing housing insecurity at the time of taking the community survey.
- **Food Insecurity:** The percentage of community members sampled who reported experiencing food insecurity at the time of taking the community survey.
- **Tobacco Product Use:** The percentage of community members sampled who reported currently using tobacco products.
- Bullying: In the absence of collecting health insurance coverage data for LGBTQ+ youth, we replaced these data points in the community spotlights with the percentage of participants surveyed who experienced bullying because of their LGBTQ+ identity.
- Community Priorities and Calls to Action: Insights from our qualitative intersectionality listening sessions that highlight the key priorities and actionable steps identified by community members.

We hope that these spotlights will serve as valuable resources for understanding and addressing the unique challenges faced by various sub-communities within the LGBTQ+ population. By raising awareness and promoting informed action, we aim to foster a more inclusive and supportive environment for all community members.





LGBTQ+ Seniors

Community Priorities and Calls to Action Identified:


- Develop training programs for healthcare providers to improve cultural competency and the proper use of pronouns and titles.
- Expand and improve transportation options, including expanded bus routes, community-directed volunteer assistance, and increased accessible parking.
- Advocate for policy changes to lower income requirements for housing, develop co-housing options, and create LGBTQ+ affirming or centered senior housing.
- Establish more intergenerational programming and social support groups through LGBTQ+ community organizations.
- Increase availability of senior discounts and affordable events, and improve promotion and marketing to ensure seniors are aware of these options.
- Simplify processes to accessing assistance programs and provide more holistic support for navigating digital and online systems.
- Fund and create positions for navigators or ombudsmen to assist LGBTQ+ seniors with accessing services and resources.
- Improve food accessibility by providing more affordable and inclusive dietary restriction options and expanding food programs to other regions/counties.



Community Priorities and Calls to Action Identified:

- Create and promote job opportunities that are accessible to LGBTQ+ individuals, including those without extensive education or experience requirements, and advocate for inclusive hiring practices.
- Establish safe havens and build dedicated LGBTQ+ communities with the necessary tools, skills, and resources for self-sufficiency.
- Increase funding for food security programs and ensure equitable distribution of food resources.
- Develop policies to increase affordable housing options and support housing stability for trans individuals and other marginalized LGBTQ+ groups.
- Expand transportation options and improve safety on public transit, particularly in underserved areas like the East Side of Cleveland.
- Promote authentic and active allvship through community involvement, ongoing education, and accountability measures to reduce performative allyship.
- Advocate for greater LGBTQ+ representation in leadership positions and media. and create campaigns that normalize and positively portray the queer experience.
- Provide safe spaces and comprehensive support for LGBTQ+ youth, including mentorship internships, and educational programs on queer topics.

"We really have a desert for LGBTQ resources and community in the south east side of town. We are barely in summit county and go north for all our services. But there's no way to connect and gain support around here. It would help to feel less alone." -Cuyahoga County Resident, Age 44


- Establish more safe spaces and LGBTQ+-affirming third spaces where individuals can feel comfortable and secure.
- Implement comprehensive sensitivity training for students, teachers, and the larger community to address homophobia and discomfort in conversations about LGBTQ+ topics.
- Develop and integrate inclusive LGBTQ+ sexuality education programs in schools • and community centers.
- Increase access to LGBTQ+-competent mental health services, including training for local therapists and promoting mental health resources.
- Enhance visibility and awareness of LGBTQ+ support in residential, educational, and organizational settings through indicators such as stickers, signs, and public statements.
- Promote public support from politicians and community leaders to create a more inclusive and supportive environment for LGBTQ+ residents.

Community Priorities and Calls to Action Identified:

- Advocate for and invest in the development of LGBTQ+-affirming mental health and addiction services, both for adults and youth.
- Increase public education and inclusive sex education about LGBTQ+ issues, working to shift the culture towards greater acceptance and understanding.
- Establish more non-faith-based support services and shelters for LGBTQ+ individuals, ensuring these resources are affirming and inclusive.
- Develop a centralized resource hub to provide easy access to information and reduce reliance on word-of-mouth and social media.
- Create and promote more safe, affirming recreational spaces and events that are not nightlife-based, such as library events, movie nights, and community potlucks.

- Secure more funding for secular treatment and support services to reduce the burden on existing organizations and improve accessibility.
- Promote fair wages and affordable housing to help LGBTQ+ individuals achieve financial stability and housing security.



- Increase outreach, education, and advertising for HIV testing, prevention, and PrEP within Lorain County.
- Develop a network to connect LGBTQ+ individuals with inclusive and affirming faithbased organizations.
- Implement sensitivity and inclusivity training in workplaces, focusing on issues such as misgendering and respecting name changes for trans and gender-diverse individuals.
- Expand support systems and resources for LGBTQ+ individuals in Lorain County, including financial assistance and counseling services.
- Conduct training for law enforcement on humanizing BIPOC and LGBTQ+ communities, addressing racial and LGBTQ+ biases.
- Organize large-scale conferences and resource connection events to provide centralized access to information and support for the LGBTQ+ community.

Community Priorities and Calls to Action Identified:


- Ensure comprehensive and inclusive healthcare for LGBTQ+ youth, with respectful treatment, easier access to gender-affirming surgeries (like top surgeries), and proper use of names and pronouns by all healthcare staff.
- Create safe exercise spaces specifically for women and non-binary individuals to engage in physical activity without fear of harassment.
- Establish clear anti-harassment policies in healthcare to prevent staff from questioning or dismissing the health concerns of LGBTQ+ youth.
- Improve access to supportive religious spaces by developing networks that connect LGBTQ+ individuals with inclusive faith-based communities.
- Strengthen school policies for LGBTQ+ inclusion by enforcing anti-bullying measures, ensuring gender-neutral bathrooms, and promoting the formation of Gay-Straight Alliances (GSA) in all schools.
- Train educators and school staff on LGBTQ+ issues, ensuring teachers use preferred names and pronouns and are proactive in addressing slurs and bullying.
- Expand resources for mental health and support, focusing on the unique emotional challenges LGBTQ+ youth face, ensuring they feel loved, supported, and safe in their environments.
- Address policing in schools, reduce over-policing and focus on creating safe environments through protective measures rather than increased enforcement.
- Enhance workplace inclusivity, ensuring all employees are respected and introducing tools like pronoun pins to create more inclusive professional environments.
- Increase inclusion in sports, allowing trans individuals to compete without restriction and developing more gender-neutral sports teams.
- Support creative and recreational outlets for LGBTQ+ youth by fostering spaces for arts, music, and sports, where they can feel free to express themselves and connect with others who care about their well-being.
- Advocate for proactive legislative changes, shifting from reactive defense against harmful laws to actively passing protections for LGBTQ+ individuals, particularly focusing on trans rights and public accommodations.

"I'm afraid I will loose my family, friends, and will be treated differently at school. Being kicked out is a real concern for me, and if I did, I would no longer be allowed to go to my high school."



Community Priorities and Calls to Action Identified:

- Outlaw conversion therapy statewide to protect LGBTQ+ youth from harmful • practices.
- Support the establishment of GSAs (Gay-Straight Alliances) in all schools, ensuring ٠ administrative backing and overcoming opposition from parents and students, while ensuring safety and support for those who want to participate.
- Expand LGBTQ+ inclusive sex education and implement classes on LGBTQ+ history, laws, and government to educate both youth and adults.
- Create affirming legal services to assist LGBTQ+ youth with name changes, legal sex changes, and navigating anti-LGBTQ+ legislation.
- Increase the availability of gender-neutral bathrooms in schools and public spaces, ٠ ensuring privacy with occupied labels on stalls.
- Reduce discrimination in employment, particularly for young queer individuals, • by establishing clearer protections against job discrimination based on gender expression.
- Facilitate access to gender-affirming clothing and resources like binders and gaffs, • and create safe spaces for LGBTQ+ youth to shop for clothing that aligns with their gender identity.
- Organize more free LGBTQ+ youth events in Geauga County, while also providing opportunities to connect with youth from neighboring areas and Cleveland to build a stronger community network.
- Offer educational workshops and sessions for LGBTQ+ youth on how to respond to harmful laws or policies, hosted in accessible community spaces like libraries.



- Expand educational offerings, including more art classes and other creative outlets. • Support GSAs (Gay-Straight Alliances) and encourage collaboration with other student clubs, like disability support groups.
- Enhance school safety, addressing bullying and violence with regular screenings and safety checks. Improve emotional support systems within schools for LGBTQ+ youth.
- Support family mediation programs to help facilitate conversations between LGBTQ+ youth and their parents.

Community Priorities and Calls to Action Identified:

- Develop comprehensive educational resources on testosterone and its side effects, ensuring accurate information is widely available.
- Train mental health providers to better understand and support transmasculine individuals.
- Implement protocols to prevent misgendering and ensure transmasculine individuals are taken seriously in all professional and healthcare settings.
- Increase research and support for trans BIPOC individuals, focusing on their unique intersections.
- Provide accessible resources and guidance for managing pre-existing conditions with testosterone use.
- Improve the training of researchers to be culturally competent and sensitive to transmasculine needs.
- Simplify and affirm the informed consent process in healthcare.
- Ensure continuous and proactive follow-up care for transmasculine patients, offering alternatives without them needing to ask.
- Advocate for the removal of insurance barriers that require unnecessary proof for treatment changes.

- Provide more comprehensive medical guidance to reduce the reliance on patients seeking information themselves.
- Enhance the supportiveness and affirmation at Pride clinics.
- Increase trust in medical professionals by improving their understanding and affirming behavior towards transmasculine individuals.
- Standardize care practices, including proper injection training, for transmasculine healthcare.
- Encourage and support more trans individuals entering healthcare professions.
- Address educational and job mobility barriers caused by early trauma.
- Reduce costs for accessing transmasculinespecific events and spaces.
- Create more everyday spaces that cater to social and professional needs of the transmasculine community.
- Promote awareness and understanding of transmasculine experiences through education and visibility.
- Organize and support trans-friendly job fairs and ensure DEI training for employers beforehand.
- Improve job assistance and resources for trans veterans, with a focus on black trans veterans.







- Enhance safety measures in digital spaces and public transit, including more safety/security staff and better enforcement of legal protections.



- Address food insecurity by creating more accessible and healthy food options and improving transportation to these resources.
- Develop and support intersectional spaces for Black LGBTQ+ individuals, fostering a sense of community and belonging.
- Implement policies and training programs to reduce discrimination in nightlife and other social spaces, ensuring inclusivity and safety.
- Enhance public transportation safety measures and provide more options for accessing healthy food.
- Improve access to healthcare by addressing systemic barriers, increasing supportive resources, and ensuring inclusive and affirming care for Black LGBTQ+ individuals.

Middle Eastern and North African LGBTQ+ Community

While this community spotlight aims to shed light on the experiences and needs of Middle Eastern and North African (ME/NA) LGBTQ+ individuals, it is important to acknowledge the limitations of our study. The ME/NA LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite having collected insights on the following community priorities and calls to action, our team would like to highlight the need for more inclusive and targeted efforts to ensure their voices are adequately heard and represented in future research and community assessments.

Community Priorities and Calls to Action Identified:

- Promote opportunities for ME/NA people in management and other power positions within the • LGBTQ+ community.
- Utilize government grant programs to repurpose empty and unused real estate, such as Airbnbs, for affordable housing for immigrants and homeless LGBTQ+ youth.
- Foster volunteering and financial assistance programs from large organizations to support emergency food, shelter, and voucher services. Implement food recycling programs.
- Develop educational resources and outreach programs to enhance understanding of religious and cultural beliefs. Include required workplace training on these topics.
- Create and distribute educational resources for LGBTQ+ education in the ME/NA community, . emphasizing safety, acceptability, and receptiveness.
- Promote Queer ME/NA safe spaces through TV ads and other confidential channels.
- Implement educational resources and required training in workplaces to combat ME/NA discrimination, focusing on microaggressions and colorism. Foster more sensitivity and language education.
- Provide educational resources and training for the LGBTQ+ community about ME/NA cultures and . intersectionality. Include outreach to physicians in training, clinical programs, and workplaces.
- Expand case management services by creating more paid positions for community health workers both within the health system and the community.
- Develop third-party representation, interpreters, financial assistance, and community outreach • to support ME/NA individuals needing resources for citizenship, documentation, and safety. Encourage support from the LGBTQ+ community to foster buy-in from the ME/NA community.

"My biggest concern as part of the LGBTQ+ community is not being fully accepted or loved by my middle eastern family once they know who I am." - Cuyahoga County Resident, Age 30

The AA/PI LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite having collected insights on the following community priorities and calls to action, our team would like to highlight the need for more inclusive and targeted efforts to ensure their voices are adequately heard and represented in future research and community assessments.

Community Priorities and Calls to Action Identified:

- Support the expansion and resourcing of existing AA/PI queer organizations like OPAWL to increase accessibility and outreach within the community.
- Advocate for education and cultural competency training within AA/PI-serving organizations to ensure LGBT inclusivity and trauma-informed care.
- Facilitate the establishment of new inter-organizational groups tailored to the diverse needs of AA/PI LGBTQ+ people, fostering community and support across generational and cultural differences.
- Promote media portrayal and visibility of AA/PI LGBTQ+ individuals, advocating for their inclusion in community events, social justice initiatives, and government policies without tokenization.
- Organize listening sessions and cultural exchanges to bridge inter-community cultural differences and foster understanding among adopted and emigrated AA/ PI individuals.

"Coming out to my Chinese immigrant parents led to me being kicked out of the house. It took me a long time to understand there will be a lot of people in life who don't love you because of who you are. But there's gonna be a lot of people who do love you. While this community spotlight aims to shed light on the experiences and needs of American Indian and Alaska Native (AI/AN) LGBTQ+ individuals, it is important to acknowledge the limitations of our study. The AI/AN LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite many attempts by our team to host intersectionality listening sessions for this part of our community we were unable to engage this important part of our community in collecting qualitative lived experiences.

Due to the lack of identifying community priorities and calls to action directly from AI/AN LGBTQ+ community members and to address these limitations and enhance future engagement and representation of the AI/AN LGBTQ+ community in future initiatives, our team proposes the following actions:

- Build trust with the AI/AN LGBTQ+ community through cultural competency
- Increase outreach and accessibility to the AI/AN community
- Strengthen community partnerships with historically trusted Al/AN serving organizations
- Promote inclusive policy and advocacy for the AI/AN LGBTQ+ community
- Provide funding and resources

By implementing these actions, we can work towards a more inclusive and representative understanding of the AI/AN LGBTQ+ community, ensuring that their voices are heard, respected, and valued in all aspects of research and community engagement.

"With being Indigenous as well as a woman, I get talked down too a lot! People have no idea what a 2 spirit person is. I have to be firm and hold my ground. I try to pave the way for the 2 spirit people's after me." - Cuyahoga County Resident, Age 43

- Develop comprehensive advertising campaigns and community initiatives to foster greater support and patronage of LGBTQ+-owned businesses.
- Create and maintain a robust LGBTQ+ business directory and network, ensuring accessibility and promotion across various platforms.
- Advocate for financial literacy programs and affordable health insurance options tailored to LGBTQ+ business owners, addressing specific needs and challenges.
- Implement mentorship programs and community-wide events focused on business development and advocacy for LGBTQ+ entrepreneurs.
- Expand educational opportunities and awareness campaigns to dispel myths and misconceptions about LGBTQ+ financial status and needs.
- Collaborate with advocacy organizations and policymakers to enhance legal protections and support for LGBTQ+-owned businesses, including certification processes.
- Promote the creation of safe spaces and inclusive policies within business communities, ensuring equitable treatment and opportunities for LGBTQ+ individuals.


Community Priorities and Calls to Action Identified:

- Establish a union for drag performers and entertainers to ensure fair compensation and accountability for cancellations.
- Promote visibility and support for sex-positive spaces such as strip clubs, bathhouses, and swinger clubs.
- Increase access to health care through organizations like Central Outreach and Planned Parenthood; provide legal services and insurance options.
- Develop educational resources and workshops on what it entails to work in drag and performing, including financial and legal aspects.
- Create more LGBTQ+-specific, sober spaces for all-age performances and events, such as drag chess nights or brunches for kids.
- Implement safety plans and protocols for performances, especially in response to resistance and threats from groups opposing all-age drag events.
- Address drug and alcohol use in performance spaces by providing alternative venues and support for those in recovery.
- Organize monthly community meetings for mentorship, networking, and sharing experiences in a neutral, non-bar setting.
- Educate bar and venue owners on the value and needs of LGBTQ+ performers, potentially through workshops like Drag 101.
- Advocate for performers' rights to refuse exploitation and demand fair treatment, booking fees, and respect as professionals.

"I don't appear LGBTQ+ enough for many, and too much for others. Usually as a drag entertainer it's the former. My biggest issue is trying to perform and do enough gigs to count as a job, while being disabled." - Lorain County Resident, Age 33

Drug and Alcohol Misuse, Addiction, and Recovery in the LGBTQ+ Community

Community Priorities and Calls to Action Identified:

- Establish trans-inclusive rehabilitation centers to ensure all individuals receive appropriate and respectful care.
- Implement gender-neutral restrooms in public spaces and recovery facilities to accommodate all individuals.
- Increase visibility and support for the sober LGBTQ+ community through public awareness campaigns and dedicated support groups.
- Develop recovery programs that specifically address and support diverse gender identities. Implement comprehensive training programs for law enforcement on issues related to trans safety and LGBTQ+ inclusivity.
- Create employment support programs that specifically assist individuals in recovery from the LGBTQ+ community to find and maintain stable employment.
- Utilize abandoned properties and increase funding to expand residential treatment and phase-based recovery options.
- Implement prevention programs for LGBTQ+ youth in unsafe family situations, including safe shelters and support homes.
- Improve the training and vetting of rehab workers to ensure they are passionate and committed to the recovery process.
- Promote unity and support at the intersection of recovery and LGBTQ+ identities through community programs and peer support systems.

"As a sober individual in recovery, the majority of LGBTQ+ events are filled with drugs or alcohol, which makes it hard to connect with the community." - Cuyahoga County Resident, Age 28



Community Priorities and Calls to Action Identified:

- Implement specialized training for healthcare providers on traumainformed care for LGBTQ+ survivors of violence.
- Advocate for policy changes to improve access to safe and supportive housing options, including reforms to Section 8 procedures.
- Establish peer support networks and community-led initiatives to provide ongoing support for survivors, addressing both social and healthcare needs.
- Promote workplace diversity and inclusion training, focusing on LGBTQ+ • issues, pronoun usage, and creating supportive environments.

"I have to exist in a way that feels like not existing. Most times, they [doctors] just tell you to get over it. People aren't worried about you; you have to worry about vourself."

Disabilities in the LGBTQ+ Community

Community Priorities and Calls to Action Identified:

- Develop and implement specialized training programs for law enforcement • agencies on interacting with autistic individuals, emphasizing communication strategies and de-escalation techniques.
- Advocate for systemic reform within the legal system to address • discrimination and ensure equitable access to legal services for LGBTQ+ individuals with disabilities.
- Establish comprehensive psychosocial evaluation protocols for prospective parents in the foster care and adoption systems, ensuring they are equipped to support children with trauma and disabilities.
- Create databases of LGBTQ+ affirming lawyers and legal services, expanding accessibility and support for individuals facing discrimination in disability and SSI legal processes.

"The lack of care or knowledge of disability and accessibility in queer spaces makes them unwelcoming. The ONLY group who has cared for us are other disabled folks. Until the queer community is ready to address its ableism it will continue to be a hostile place for a lot of folks." - Lorain County Resident, Age 37

LGBTQ+ People Living with HIV/AIDS (PLWHA)

LGBTQ+ community members living with HIV/AIDS who are over the age of 18 and reside in Cuyahoga, Lake, Lorain, or Geauga county.

Community Priorities and Calls to Action Identified:

- Establish dedicated funding and grant programs for transitional housing tailored to PLWHA, ensuring ongoing support beyond case management.
- Advocate for policy changes to recognize HIV/AIDS as a qualifying condition for SSI, streamlining the application process and providing necessary financial support.
- Expand outreach efforts and create centralized hubs for accessible and inclusive dissemination of HIV care resources, both digitally and physically.
- Collaborate with healthcare providers to enhance cultural competency and reduce stigma in HIV care settings.
- Promote peer support programs and mentorship initiatives within the community to foster a supportive network for PLWHA, including buddy programs and support groups.

"I have Medicaid and am HIV positive and am worried about making more money and losing my insurance, but cannot move out of my housing situation unless I make more right now. I know that there are programs that will help cover medical costs if I lose my insurance but I am afraid of trying to navigate those changes."



Community Priorities and Calls to Action Identified:

- Advocate for the creation of separate, safe spaces within prisons for LGBTQ+ individuals to ensure their safety and well-being.
- Implement comprehensive LGBTQ+ sensitivity and cultural competency training programs for prison staff to reduce discrimination and mistreatment.
- Establish supportive programs that address economic disparities and provide access to affordable healthcare, including hormone treatments, both during and after incarceration.

"Prison is not a safe place to be openly 'out,' especially in the general population. There needs to be a separate space for safety. It's more accepted and safer in women's prisons compared to men's." - Cuyahoga County Resident, Age 45

"I still have concerns about police and Law Enforcement. Having experienced abuse during a mental health crisis, I just can never trust them."

Community Priorities and Calls to Action Identified:

- Advocate for the training and certification of more counselors specializing in transgender youth.
- Create centralized resource hubs to reduce the burden on parents and guardians searching for information and support.
- Develop and promote networks for parents to connect, share information, and support each other.
- Identify and promote affirming churches, and use these spaces as community hubs for support and resources.
- Encourage school systems to collaborate with community organizations and parent groups to address fear of pushback and promote inclusive policies.
- Offer life skills training for parents and caregivers to better support their LGBTQ+ youth in transitioning to adulthood.
- Increase the promotion and availability of gender-neutral recreational activities and spaces.
- Improve access to gender-affirming clothing through local initiatives and partnerships.
- Provide guidance and safety plans for navigating social media and balancing visibility with safety, particularly in rural areas.
- Establish and support Gay-Straight Alliances (GSA's) in schools to provide safe spaces and resources for LGBTQ+ youth.
- Develop resources and support systems for neurodivergent LGBTQ+ youth.
- Enhance the visibility of affirming symbols and messages in the community.
- Offer guidance and education for parents and caregivers on how to support their LGBTQ+ children's friendships and relationships.
- Provide comprehensive, science-based sex education that is LGBTQ+ affirming for both parents and youth.
- Develop and implement allyship training programs for parents and caregivers to better understand and support the LGBTQ+ community.

"I am concerned for my child's safety. They are gender-fluid and the county isn't exactly the most welcoming place. I worry less about myself because I am able to stay closeted in situations that I wouldn't feel safe in."

- Increase diversity and visibility across the LGBTQ+ spectrum through inclusive events, educational programming, and better marketing strategies.
- Develop and promote trusted, vetted resources related to kink safety and sex education by unifying efforts of existing organizations.
- Foster acceptance of kink events at non-kink-specific locations to bridge the gap in perception and reality.
- Create more substantial and inclusive multimedia representation, including local films and social media presence, to educate and maintain communication.
- Improve access to affordable kink gear and merchandise, ensuring guidance and instructional assistance are available.

"The kink community is built on community. The way I see it, believing in one another and fostering growth together is paramount. We can't keep our community alive without supporting one another." - Summit County Resident, Age 27

"The current climate of anger towards our community and lately even locally, the Sisters of Perpetual Indulgence, of which I am a member, is being targeted. I'm afraid for my safety some of the time."

Despite having collected qualitative insights on the following community priorities and calls to action, our team would like to highlight the need for more inclusive and targeted efforts to ensure their voices are adequately heard and represented in future research and community assessments.

Community Priorities and Calls to Action Identified:

- Establish safety protocols and resources for sex workers, including self-defense workshops, realistic self-defense items, and safety check-in systems through apps or social media.
- Advocate for accessible housing programs and emergency transitional housing options tailored to the needs of sex workers, ensuring stability and safety.
- Develop comprehensive support programs that include life skills workshops, education
 opportunities, and career development initiatives to empower individuals to transition out of sex
 work.
- Enhance healthcare access and support for sex workers, including onsite testing for STIs, cultural competence training for healthcare providers, and destigmatization of sex work in medical settings.

"Back in the day- we used to look out for each other. It's not the same anymore. These kids need a phone app to help with safety [when engaging in sex work]. - Cuyahoga County Resident, Age 62

"It's a social issue that no one wants to talk about because of the stigma surrounding it. You're looked down on, treated as if you're beneath others. I needed to do it to eat, to survive. I hate the way people judge."
